The Province Dairy Development Board, Bagamati Province, Hetauda has received a grant from GoP towards the cost of **Construction of Milk Powder Plant and Processing Plant at Hetauda, Makwanpur** and intends to apply part of the funds to cover eligible payments under the Contract for Construction of Milk Powder Plant and Processing Plant at Hetauda, Makwanpur and Contract ID: PDDB/BA/2077/78/NCB/WORKS/02. Bidding is open to all eligible as per Section V of bidding document.
- 2. Province Dairy Development Board, Bagamati Province, Hetauda invites electronic bids from eligible bidders for the Construction of Milk Powder Plant and Processing Plant at Hetauda, Makwanpur under National Competitive Bidding Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: NRs. 564,500,000.00
- Minimum Work experience of similar size and nature: at least One(1) Construction of RCC Frame Building Builtup Area 500.00 sq.m. and at least One(1) construction of milk powder plant/construction of processing plant: Contracts within the last ten (10) years, each with a value of at least NRs 150,000,000.00
- 3. Eligible Bidders may obtain further information and inspect the Bidding Documents at the office of **Province Dairy Development Board**, **Bagamati Province**, **Hetauda** or may visit PPMO e-GP system www.bolpatra.gov.np/egp.
- 4. Bidder should submit their bid electronically only and may download the bidding documents for e-submission from PPMO's e-GP system www.bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost NRs. 20,000.00 of bidding document in the Project's Rajaswa (revenue) account as specified below.

- Electronic bids must be submitted to the office Province Dairy Development Board, Bagamati Province, Hetauda through PPMO's e-GP system www.bolpatra.gov.np/egp on or before 2020-11-22 at 12:00Hrs. Bids received after this deadline will be rejected.
- 7. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2020-11-22 at 13:00 Hrs at the office of Province Dairy Development Board, Bagamati Province, Hetauda. Bids must be valid for a period of 120 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs.11,260,000.00, which shall be valid for 30 days beyond the validity period of the bid.
- 8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
